"REGENERATIVE PERIODONTAL ENDOSCOPY: The Future is NOW!"

Course description:

In a recent interview asking about Hygienists' role in tissue engineering, Dr. William Giannobile recognized that "...In the future, regenerative therapies could be as simple as the local delivery of regenerative molecules placed sublingually to promote repair of periodontal and gingival defects. New drug delivery systems to stimulate wound repair of soft tissue and extraction defects may be as simple as applying medicaments directly to wounds..."

This course describes the science behind a new closed periodontal treatment procedure, performed by hygienists, that utilizes a combination of treatment modalities in a specific order that work synergistically to achieve rapid radiographic bone fill. With the development of an affordable, third generation dental endoscope on the horizon, there is the hope that this innovative conservative regenerative procedure will soon become mainstreamed, offering an exciting alternative treatment option for patients with advanced periodontal destruction.



This past August, I had the honor of being a GC America scholarship recipient to CareerFlow West Retreat in San Francisco. This was a life changing experience for me in more ways than one. I learned so many new skills to branch out of my clinical dental hygiene Career, met new lifelong friends and business associates, but most importantly I got to meet Debra Green. Debra is an RDH who was seriously injured in an auto accident 3 years ago. She is now a quadriplegic. Her two friends and fellow RDH's Lori Brogna and Sandy Pierce accompanied Debra on the 12-hour van ride to California from Utah. Sandy and Lori have shown what true friends are as they took care of Deb's needs during the entire trip.

Deb needs to reinvent her clinical dental hygiene career that she loves so much as she can no longer practice. In speaking with Deb I found out she would like to educate at long term care facilities on oral hygiene care. When Deb awoke after her accident the staff at the facility was not maintaining her oral hygiene. While also speaking with Deb I found out that she had borrowed a laptop from a friend (Lori) to come to Career Flow and she had no money to buy one. Once I heard this the wheels in the back of my head-starting turning, it was almost that I couldn't get Deb out of my mind unless I did something about this. I kept thinking that if I needed extra money, I had my two hands and could work if necessary. Deb didn't have that option. It was then that I decided that I wanted to fundraise for a laptop computer, software and accessories so that Debra would have the tools she needed to start her new facet of her career.

From CareerFlow I called my friend Sandra Berger and told her my idea and how I had to do something to help Deb get started. She thought it would work. Once home I contacted Sandy and Lori and they thought it was a great idea as well. I contacted Kristy Menage Bernie and Beth Thompson (co-founders of CareerFlow) and asked if it was ok for me to use the CF email list of faculty and fellow attendees to start my fundraiser. The response of people has been amazing. I have received so many beautiful notes wishing Deb good luck and thanking me for my efforts. I have to say that recognition was never on my mind when starting this project. This has truly been a group effort.

ADHA Ambassador Program in Russia and Poland: An Experience of a Lifetime

Representing ADHA and traveling to St. Petersburg, Russia and Warsaw, Poland with fifty-two American dental hygienists and guests was a once in a lifetime journey. Organized by the People to People Ambassador Program and ADHA, co-leaders Marge Green, RDH, MS and Irene Connolly, RDH, MS, our role as Ambassadors was to have a professional exchange with Russian and Polish dental health care public officials, professional leaders, administrators, educators, practitioners and public health dental hygienists.

For nine days in the summer of 2007, our group toured both cities to learn about the political, cultural, and social changes that have occurred over centuries. Relatively recent political restructuring, post-Soviet period, has led to increased western influences, commercial opportunities and free enterprise that has resulted in some drastic changes.

While in St. Petersburg, we attended and toured cultural events and landmarks. In Poland, we were reminded of the destruction of lives and property during WWII and the bravery and strength of the Polish people to overcome oppression and rebuild their cities.

During our visit, nine meetings and tours were arranged with the local dental hygiene faculty, public health officials, and practicing dental hygienists at public and private dental health clinics, medical centers and agencies. As dental health care professionals, the primary goal of our delegation was to attain a better understanding of the oral health care system in policy and delivery of services and its accessibility for people of Russia and Poland. Through a professional exchange, we shared the similarities, differences, and challenges we face as health care providers regarding education standards, practice, employment circumstances and other relevant professional issues.

Russia

At the Ministry of Health, our group met with the key health professionals of Russia and discussed general practices in health care. The government healthcare system in Russia guarantees and regulates medical healthcare. Needs assessments are done before the state budget is finalized. Free healthcare and some dental care services are provided in clinics and financed through state insurance. The general public does not have dental insurance; therefore, they do not use dentistry for prevention.

There are currently 1,000 private dental clinics in Russia and 80,000 dentists for 140 million patients. TV advertising and selling dental and hygiene packages, which include prevention, are growing in popularity.

The water system is not fluoridated because it is viewed as a medical application. Fluoride is relied on from dental products and bottled water. Sealants are also not part of public health practice. Sixty to ninety percent of school-aged children have caries. Disease prevention is a priority.

Dental hygiene is a two-year program. The Medical College #3 trains Oral Hygiene Specialists for free with the intent that they will serve the state public dental clinics. Many hygienists, however, pursue private practice instead.

Poland

The Polish Dental Hygiene Association officially began in 2003. This year, legislation is anticipated to be introduced for the licensing of dental hygienists. The study of dental hygiene there began in 1973. It has since been broadened to two years and a diploma is earned upon graduation from a public or private college.

In Poland, caries frequency in children up to age three is twenty percent. By age six, caries frequency is ninety percent. Basic dental treatment is free of charge. The water is not fluoridated and fluoride is applied only in post eruption dentition.

After graduation from dental hygiene school, hygienists seek employment mostly in private dental office settings. Jobs are hard to find because dentists are not familiar with the duties or misunderstand the role of the dental hygienist. Also, patients generally don't seek oral health and disease prevention care. Dental hygiene is a relatively new concept in these countries. Under former political structures, the general population was treated for dental maladies, often times without anesthesia. Fear of dental care is still prevalent.

With the recent expansion of public dental care services, dental insurance, public education, and professional training, dental health prevention should become common practice. The Polish Dental Hygiene Association, for example, is campaigning for Preventive Oral Health Care. A public health concern discussed by the profession is the wide use of to-bacco products in the young and adult general population.

Dental hygienists provide services under general supervision. Services rendered by dental hygienists include dental and periodontal exams, power, and manual scaling, polishing, sealants, and fluoride treatments, whitening procedures, inventory control, documentation and administrative duties. X-rays are not part of the dental hygiene curriculum and are the duty of dental radiology technicians. Fees for service are through public finance and national service.

We were fortunate enough to visit an orphanage and foster home in Warsaw. The children were well cared for and can reside in the orphanage until the age of 18. We provided group instruction through interpreters and one-on-one instruction to children and teenagers in oral and general care.

This experience with my fellow ambassadors, guests, and international colleagues was an amazing personal and professional journey. The experience of sharing an intellectual exchange with my peers in other countries and realizing we are all striving for the same goals was worth every moment.

The "Give Kids A Smile" program provided dental examination and education to over 900 needy children in the community during Dental Health Month. Dr. Michael Shreck (Nassua Dental Society) organized the event and the teams of participants from a local High School as well as the staff and students from Farmingdale State College, Long Island Jewish Hospital & North Shore Hospital. During the program 65 children were diagnose with caries and other dental needs.

Fellowship Application Procedures and Deadlines

The following regulations apply to members who are seeking the award of Fellowship in The American Academy of Dental Hygiene (FAADH). Members who have met all requirements and choose to apply for the Fellowship must complete an application.

Applications for the Fellowship Award must be postmarked by **July 1st, 2008** and sent to Executive Director to be considered for convocation that same year.

Applications received by the July 1st, 2008 deadline will be reviewed by the Fellowship Review Committee. Applicants will be informed by letter regarding AADH action by August 1st. All new fellows are encouraged to attend a special ceremony held during the AADH Annual Meeting.

A \$25 application fee is required and must accompany the award application.

Requirements in effect at the time of your membership will apply to your records. Membership in AADH maintains Fellowship status. Requirements for future members may change.

- 1. Be a active full or life member of the Academy for at least three (3) years.
- 2. Provide documentation of achievement of a Baccalaureate degree or higher.
- 3. Be elected by 3/4 vote of the Governing Council.
- 4. Fulfill 3 of 4 additional criteria.
 - A. Document advanced education of at least 100 hours in the specialty or field.
- B. Document active participation in the specialty or field via practice, published research or poster/clinic presentations at national or international hygiene meetings, or having served elected leadership positions in hygiene associations.
 - C. Present a continuing education course which meets AADH guidelines for course approval.
 - D. Advanced the cause of the specialty/field in some community related significant manner.
